## PRINCESS INFORMATION & RULES

- Deadline For Entries:** August 15, 2015 before 5:00 p.m.  
(In the event an entry arrives after the deadline, the applicant will be notified and the entry fee returned. No entry fee will be refunded for cancellations or no shows.)
- Date of Contest:** Saturday, September 5, 2015
- Location of Contest:** Anahuac ISD Auditorium
- Contest Time:** 2:00 p.m. - Contestants required to be dressed and checked in at 1:00 p.m.
- Entry Fee:** \$50.00 due upon receipt of application, made payable to Texas GATORFEST
- Photo:** Please contact Teri with Fort10berry at 936/402-2558 to schedule your appointment. Deadline for photos is Wednesday, August 19, 2015. Please note that your child should not wear anything grey - any other color is perfectly acceptable.
- Eligibility:** Applicant is a Chambers County resident, or at least one of applicant's parents (mother or father) is a Chambers County resident enrolled in the third or fourth grade, as of September 1, 2015. Limited to the first 20 applicants.
- Dress:** Pageant dress.
- Rehearsal:** Rehearsal for Stage Competition September 4, 2014 at the Jr. High Auditorium.
- Contestant Rules:**
1. The decision of the judges will be final.
  2. Sponsor fees are not refundable.
  3. Good sportsmanship is required at all times. Contestants, their parents and or representatives agree to work with GATORFEST volunteers and staff in a positive manner. Any contestant, their parent(s) or representative exhibiting an unprofessional, unsportsmanlike or unethical code of conduct will result in contestant being asked to leave the pageant and forfeit their entry fee.
  4. The contest winner(s) agree by their submission of entry that if they will be available for festival appearances on all the days of the festival: Friday, September 11 through Sunday, September 13, 2015 at times to be specified at a later date by festival and pageant officials.
  5. The winner of the Texas Gatorfest Princess Contest may not compete for another title in any other pageant during her reign.
  6. By submitting this application, each contestant, their parent(s) or representative agrees to abide by the rules of Texas GATORFEST and the Princess Pageant. Applicant also by submission of their application assumes all risk of property or bodily injury (including death), which might occur during their participation. **PRINCESS CODE OF CONDUCT AGREEMENT**

As a representative of the Texas GATORFEST Pageant, titleholders agree to the following guidelines for conduct during her reign:

1. I will not participate in harmful, malicious, inflammatory, defaming or slanderous speech towards the Texas Gatorfest.
2. I will not consume and/or use alcohol and/or illegal drugs while participating in any function or event from the beginning of my reign until the end of my reign while representing Texas Gatorfest.
3. I will remember that my Facebook, Twitter, Instagram, Snapchat, Vine or any other social media page are considered a reflection of me as a titleholder and the Texas Gatorfest. Any and all sexually suggestive photos and verbally explicit comments must be removed during my reign. I will allow pageant officials to view and monitor all of my social media accounts.
